Budget disappointing; accounts not balanced, currency depreciated, exchange unfavourable; trying to satisfy too many factions; incidence of taxation; summer trade; stability not finality; sales tax; pyramiding; passing on to farmer, housewife and labourer, 2912; cigarette tax; income tax; production and revenue lessened; based on fallacy that taxation of rich relieves poor; Mr. Otto H. Kahn; income tax reduction in United Kingdom and United States, 2913; capital diverted from industry to tax free bonds; immigration and investment discouraged; graduated income tax; alternative between new taxation or economy, 2914; ministers' salaries and members' indemnities; aristocracy of spending; civil service; finances complicated; ordinary and war expenses should be specially provided for, 2915; substitution of turnover for sales tax; farmers and the tariff; price comparison between Canada and United States; William Henry Seward on United States tariff, 2916; not enough protection; reciprocity in tariff taxation; imports of agricultural products; farmers' national policy; reciprocity proposals, 2917; reciprocity agreement of 1911; United States out for themselves; war debts; United States would "crash through any agreement"; 2918; Fordney-McCumber tariff, 2919
