## STATEMENT ON REPORTED PRINTING OF PENSION CHEQUES IN U.S.

On the orders of the day:

Hon. George H. Hees (Minister of Transport): Mr. Speaker, yesterday the hon. member for Moose Jaw-Lake Centre asked the following question:

Is the minister aware of the fact that on a pension cheque stub of the Canadian National Railways... there appears in very fine print the words "printed in U.S.A."? Is it necessary for a Canadian public utility to have its employees' pension cheques printed outside of Canada?

I said I would make inquiries, and have now been advised by the management of the Canadian National Railways that when the machine accounting system was installed the specialized punched cheque was not available and could not be produced in Canada. Arrangements have since been made to have these specialized forms printed in Canada, and when the stock on hand is exhausted the Canadian produced form will be used.

# COMMONWEALTH CONFERENCE

REQUEST FOR STATEMENT ON TRADE AND ECONOMIC MEETING

On the orders of the day:

Hon. Paul Martin (Essex East): I should like to ask the Minister of Finance if he can tell us now if all commonwealth countries have accepted the proposal for an economic and trade conference, and can he at the same time indicate to the house whether there is any reason to believe the conference may take place much earlier than expected, as I understand was suggested in a London paper this morning, perhaps some time toward the end of March?

Hon. Donald M. Fleming (Minister of Finance): Mr. Speaker, definite acceptances have been received from nine of the eleven commonwealth countries, and the other two have indicated that they are favourable, as were their ministers of finance at the time of the Mont Tremblant conference. A definite answer may be expected from them very soon.

As to the second part of the question, I am not aware of any report from London about expediting the plenary conference. What is being held in London early in February is the first of the meetings of officials in preparation for the plenary conference. According to present plans, preliminary meetings of the officials will be held in two stages, one early in February in London and the other probably in May. As to the date of the plenary conference, it has not yet been finally determined, the preference of some countries tion of the Minister of Trade and Commerce [Mr. Speaker.]
