Mr. Favreau: No decision regarding prosecution or other criminal proceedings in respect of alleged contraventions of the substantive provisions of the Combines Investigation Act is made unless and until a report is received from the restrictive trade

practices commission or evidence is referred to the attorney general of Canada by the director of investigation and research. No report regarding the industry concerned has been received since the report of the commission concerning the sugar industry in eastern Canada dated February 3, 1960, as a result of which prosecution proceedings have already been taken, nor has evidence been referred to the attorney general by the director.

Annual mean levels of the St. Lawrence river at Prescott, Ontario have been substituted for those at Ogdensburg, New York, but as these points are on opposite sides of the river the water levels at one are reflected at the other. Water levels are expressed in feet above mean sea level referred to the international great lakes datum (1955) and flows, in cubic feet per second.
