## REVISION IN BACON PACKAGES

## Question No. 1,076-Mrs. MacInnis (Vancouver-Kingsway):

- 1. Has the Consumers' Association of Canada, since 1959, been asking for a package that will allow consumers to see one whole slice of bacon and the distribution of fat and lean at the time of purchase?
- 2. Did the government in February, 1965, ask meat packers to revise their packages by January 1, 1966, to remove any element of deception and, if so, was the deadline extended to May 1, 1966 and for what reason?
- 3. Will the government on May 1 insist on a paskage that will permit consumers to see one whole slice of bacon at the time of purchase?

### Hon. A. J. MacEachen (Minister of National Health and Welfare): 1. Yes.

- 2. Yes. The deadline was extended when it was learned that it was not possible for the packaging industry to supply sufficient new bacon packages by January 1, 1966.
- 3. On and after May 1, 1966, the Department of National Health and Welfare will insist that all bacon shipped by meat packers is contained in packages which are not deceptive. It is considered that the requirements of the Food and Drugs Act will be met if the window area is at least two thirds of the length of the package, permits the consumer to see the full width of a slice of bacon and the package is not deceptive in any other wav.
