## **REPRESENTATION ACT, 1984**

Mr. J. R. Ellis (Prince Edward-Hastings) moved for leave to introduce Bill C-242, an Act to stabilize the representation in the House of Commons.

Given that, in my opinion and that of many others, there is no need to enlarge the number of MPs, this Bill will spare the public from further confusion and expense on this account during the 1980s.
