Bill C-26, An Act respecting the organization of certain scientific activities of the Government of Canada—Chapter No. 24.

Bill C-50, An Act to amend the Judges Act and other Acts in respect of judicial matters—Chapter No. 25.

Mr. Goodale: That is correct, Mr. Speaker.

Mr. Knowles (Winnipeg North Centre): It will come on some time in July.

Mr. Goodale: Mr. Speaker, July is not far off—one day.

Mr. Speaker: Order, please. It being after six o'clock, this House stands adjourned until eleven o'clock tomorrow morning.
