Trading was irregular, running into specialties and undetermined in character.

RIBOO DECLARES A DIVIDEND.

Altogether nine issues were dealt in, embracing some 18,000 shares; transactions were mostly in the lower priced stocks, the

dividend payers being entirely neglected.

The shipment of ore from the Slecan district for October was not quite up to the September average.

The Hambler Cariboo is again a new aspirant for dividend honors, having just declared its third dividend. The directors have ordered the payment of 1 per cent. per share, payable on Dec. 1st. The amount to be expended will be \$10,500. The capital stock is 1,250,000 shares of \$1 each. The return of the Rambler Cariboo into the list of dividend payers is another evidence of the intrinsic worth of the Slocan stocks, and also of the district. The company had previously paid two dividend.
