

Speaker's Rulings—Concluded

7. Proposed amendment of Mr. Drew to motion of Mr. St. Laurent *re* precedence for Government Business; and hours of sitting of the House, ruled out of order on the ground that Debate thereon would be the same as on a proposed Resolution (*re* Old Age Pensions) now standing on the Order Paper under Government Notices of Motions for consideration in Committee of the Whole during the present session. Ruling appealed and sustained (yeas 149; nays 44), 384.
8. Motion for leave to introduce a bill *re* Canadian National Railway Line in the City of Oshawa, ruled out of order on the ground that it involved the expenditure of public money and could not be introduced by a private member, 409-10.
