8. Has the government made a response to the latest recommendations of the Canadian Consultative Council on Multiculturalism and, if so, what is the nature of that response?—Sessional Paper No. 301-2/1,362.

Mr. Reid, Parliamentary Secretary to the President of the Privy Council, presented,—Return to the foregoing Order.

After debate thereon, the question being put on the motion, it was agreed to.
