##### SLAUGHTER OF SEALS—DISPOSAL OF CARCASSES

**Hon. H. J. Robichaud (Minister of Fisheries):** No, Mr. Speaker; in most cases they are not used commercially.

**Mr. Lloyd R. Crouse (Queens-Lunenburg):** A supplementary question. I listened carefully to the statement of the minister today and I know of the great interest in this matter; but in an effort to control the sealing industry would the minister give consideration to issuing licences to cover the quota in the gulf of 50,000 only to licensed inshore and deep sea fishermen? With this action he would, I believe, curtail the indiscriminate hunting of seals by people using aircraft and other means.

**Mr. Robichaud:** No, Mr. Speaker, it is not my intention to do this. I believe it would be pure discrimination and I do not think we could allow this in this country. I believe we have other ways of keeping full control without having to take such measures as suggested by the hon. member.
