## PROVISION OF ASYLUM FOR TECHNICAL EXPERTS FROM CZECHOSLOVAKIA

On the orders of the day:

**Mr. R. N. Thompson (Red Deer):** Mr. Speaker, my question is directed to the Minister of Manpower and Immigration. Can the government inform the house whether it is granting asylum to defecting Czechoslovak nationals who are leaving their employment as technical experts in different countries of the world to come to Canada, as did a number from India in the last few days?

**Hon. Allan J. MacEachen (Minister of Manpower and Immigration):** Mr. Speaker, our policy is directed to refugees from Czechoslovakia.

**Mr. Thompson (Red Deer):** I have a supplementary question. I wonder if the minister could tell us whether Czechoslovak nationals who are in Canada will be made eligible for student loans for professional retraining.

**Mr. MacEachen:** Mr. Speaker, the matter of assistance for students from Czechoslovakia who are refugees is under consideration.

**Mr. Thompson (Red Deer):** These are not students; they are professionals.

The tenders for the demolition of Cité du Havre in Montreal are closing at three o'clock this afternoon. Two days ago I gave notice to the Minister of Transport of the questions I intended to ask him.

Therefore, I ask any member of the cabinet, through you, Mr. Speaker, if the government intends to demolish the Cité du Havre in order to allow the real estate company to submit plans for the establishment of a Canadian film city or site there? It is a \$12 million proposal—

**Mr. Valade:** Mr. Speaker, on a point of order.
