- 2. What was the nature and purpose of such correspondence and the enclosures?
- 3. Has the Prime Minister referred the correspondence to the Minister of Manpower and Immigration and has such correspondence been acknowledged and, if not, for what reason?
- 4. Has any action been taken on the purport of this correspondence from Mr. Heakes and, if so, by whom and to what effect?
- 5. Has the RCMP conducted an investigation of Mr. Heakes as a result of this correspondence or otherwise and, if so, with what result?

- 4. Yes. An appointment was arranged with the Superintendent of Bankruptcy to permit Mr. Heakes to discuss his difficulties but Mr. Heakes has declined to meet this Official.
- 5. Mr. Heakes has directed a number of letters to the Solicitor General and to the Royal Canadian Mounted Police and has periodically come to Ottawa and visited various government offices. He has requested in this correspondence and in these visits that aspects of the bankruptcy referred to in Part 2 be investigated but pending his decision to discuss these problems direct with the Superintendent of Bankruptcy, these investigations have not been pursued.
