PARLIAMENTARY COMMITTEES' RECOMMENDATIONS—MOTION UNDER S.O. 43

Mr. Stan Darling (Parry Sound-Muskoka): Madam Speaker, I rise under the provisions of Standing Order 43. Within the past two months two committees of Parliament, one from this House and one from the other place, presented separate reports on the status of Canada's regular and reserve military forces. Both reports provided in some detail the need to strengthen and improve immediately the military, which is undermanned, ill-equipped, underfunded, and lacking in planning and direction. In light of the fact that the decline of the military over past years is the direct result of deliberate neglect by this government, and that both reports urge the government to give priority attention to our defence forces, I move, seconded by the hon. member for Simcoe North (Mr. Lewis):

That the Prime Minister order the Minister of National Defence to prepare and table a new white paper on defence as soon as possible and that the Prime Minister publicly and immediately announce his commitment to the enhancement of the status, capability and role of the regular and reserve forces in Canada.
