### REINSTATEMENT OF KATIMAVIK PROGRAM

M. Alfonso Gagliano (Saint-Léonard-Anjou): Mr. Speaker, I also have eight petitions from hundreds of people throughout Quebec who ask that the decision to cancel Katimavik be reconsidered. These petitions have been certified and they are in order.

Mr. John Nunziata (York South-Weston): Mr. Speaker, I also have nine petitions with many signatures. The petitioners state that the Katimavik program has been a success, both as concerns the training received by the 20,000 young participants in the program during the last ten years, and the major community projects undertaken by these young volunteers in Canadian municipalities during this same period.

The petitioners ask the Parliament of Canada to reconsider the decision to cancel Katimavik.

I have as well four other petitions containing the names of approximately 130 or 140 petitioners. The petitioners state that in the opinion of the friends of Katimavik, the federal Government's decision to cancel the youth program Katimavik is a short-sighted budgetary measure at the expense of Canadian youth. The petitioners request the Conservative Government of Canada to reinstate with full funding the Katimavik program for the young people of Canada.

Mrs. Sheila Finestone (Mount Royal): Mr. Speaker, I was just counting the pages and found that there are over 30 pages with 30 signatures per page in one petition which has been duly authorized. I have the privilege to present this petition which deals with the fact that the cancellation of the Katimavik program which helped thousands of young Canadians develop social skills and employment options while providing them an opportunity to do useful community work in different regions of Canada has brought serious concern to parents and they ask Your Honour to please consider reinstating the Katimavik program.

ABORIGINAL AFFAIRS AND NORTHERN DEVELOPMENT— AUTHORIZATION TO TRAVEL

Hon. Ray Hnatyshyn (President of the Privy Council): Mr. Speaker, there are three items that I would ask to be dealt with by the House now and these items will be dealt with on the basis of discussions between Parties. Agreements have been arrived at with respect to the orders.

The first deals with an order with respect to the Standing Committee on Aboriginal Affairs and Northern Development, and I think you would find a disposition to receive by unanimous consent and have passed without debate the following order:

That the Standing Committee on Aboriginal Affairs and Northern Development be empowered to travel to the Sechelt Indian Reserve in the Northwest Territories and the Yukon during the period April 20, 1986, to May 2, 1986, and that the necessary staff accompany the committee.
