#### YOUNG OFFENDERS ACT

Question No. 384-Mr. Howie:

What is the estimated cost to (a) Canada (b) the provinces of the adoption of the uniform maximum age of 18 years under Young Offenders Act?

Hon. Bob Kaplan (Solicitor General of Canada): The federal Government is currently involved in detailed negotiations with the provincial governments concerning federal financial assistance to juvenile justice services administered by the provinces. Estimates of the costs to, (a) Canada, (b) the

provinces, of the uniform maximum age provision of the Act will not be available until these negotiations are concluded. The initial evaluation by the federal Government of the cost impact of the legislation indicates that the Act will not result in an untoward increase in over-all criminal justice costs for either Canada or the provinces.

#### STUDIES RELATING TO INCARCERATION OF CRIMINALLY INSANE

## Ouestion No. 409-Mr. Howie:

Did the Solicitor General undertake any studies relating to the incarceration of criminally insane persons and, if so (a) were these studies conducted by outside consultants (b) in what time frame were the studies to be conducted (c) was any amount allocated to the studies and, if so, what amount?

Hon. Bob Kaplan (Solicitor General of Canada): No. (a) to (c) Not applicable.

#### Question No. 410-Mr. Howie:

Did the Minister of Justice undertake any studies relating to the incarceration of criminally insane persons and, if so (a) were these studies conducted by outside consultants (b) in what time frame were the studies to be conducted (c) was any amount allocated to the studies and, if so, what amount?

Hon. Mark MacGuigan (Minister of Justice): The Ministry of Justice has undertaken several studies dealing with criminally insane persons. The main effort in this area in the mental disorder project which began in the fall of 1982 as part of the Criminal Law Review. This study involves research on both the legal and social science areas relevant to the mentally disordered offender. Following the publication and distribution of a discussion paper last summer, extensive consultations were conducted with provincial governments, with major national and provincial organizations and associations, and with Lieutenant Governors' Advisory Review Boards. At present, officials within the Department of Justice are formulating recommendations based on the information obtained through research and consultations.

In addition to departmental study, outside consultants have been retained. A complete list follows under the heading mental disorder project. In addition to this extensive study a number of smaller projects relating to the mentally disordered offender have been sponsored by this department. This list, entitled "Discretionary Federal Projects-Mental Disorder", follows as well.
