Mr. Axworthy: Mr. Speaker, it is all for the sake of information. The people of Toronto also protest this action.

Along with the people of Toronto we have their wonderful neighbours in Scarborough North. They also wish to present a petition on behalf of children and families. Just slightly to the other side of Toronto we have a petition from people in Hamilton-Wentworth.

Mr. Speaker: Order, please. I invite the Hon. Member to conclude as briefly as possible.

Mr. Axworthy: Hamilton-Wentworth is a very long word and I want to get it out clearly.

USE OF NANOOSE BAY TEST RANGE

Mr. Jim Manly (Cowichan-Malahat-The Islands): Mr. Speaker, I have a number of petitions here on different subjects.
