In fact these amounts, which are provided for in the long-term agreement with France and the EEC, and as well the allocation in the 3PS area, are contained within the fishing plan which was announced last year, fully discussed and negotiated with representatives of the industry and the Governments of Newfoundland and the other Atlantic Provinces.
