**W**HEREAS provisional articles of Agreement were entered into on the twenty-eighth day of January, in the thirty-seventh year of Your Majesty's Reign, by Commissioners nominated and appointed on behalf of this Province, to treat with Commissioners nominated and appointed on behalf of the Province of Upper Canada, which said Articles of Agreement were ratified and confirmed by An Act of the Legislature of this Province passed also in the thirty-seventh year of Your Majesty's Reign, intituled, "An Act to ratify, approve and confirm certain Provisional Articles of Agreement, entered into by the respective Commissioners of this Province and Upper Canada, at Montreal, on the twenty-eighth day of January, one thousand seven hundred and ninety-seven, relative to Duties, and for carrying the same into effect," which said Articles of Agreement, have not hitherto been ratified, approved and confirmed by the Legislature of Upper Canada; and whereas, another Act was passed by the Legislature of this Province in the thirty-eighth year of Your Majesty's Reign, intituled, "An Act to repeal an Act passed in the thirty-sixth Year of the Reign of His present Majesty and for appointing other Commissioners on behalf of this Province, to treat with Commissioners on behalf of the Province of Upper Canada, and for the purposes therein mentioned," in virtue whereof additional Provisional Articles of Agreement were made and entered into at Montreal, on the eleventh day of February, in the thirty-ninth year of Your Majesty's Reign, by a competent number of the Commissioners thereby nominated and appointed, and the Commissioners nominated and appointed, on behalf of the Province of Upper Canada, under authority of an Act passed by the Legislature of that Province, in the thirty-seventh Year of Your Majesty's Reign, intituled, "An Act to authorise the Lieutenant Governor to nominate and appoint certain Commissioners for the purposes therein named;" which additional Articles follow:

**ARTICLE I.** "That the Legislature of the Province of Upper Canada, may ratify the aforesaid Provisional Agreement, with a condition, suspending the operation and
