

*Resolved*, That the Bill do pass, and the title be, "An Act to incorporate the Royal College of Physicians and Surgeons of Kingston."

*Ordered*, That the Clerk do carry the Bill to the Legislative Council, and desire their concurrence.

A Bill to enable *Casimir Stanislaus Gzowski* and the Honorable *David Lewis Macpherson* to obtain Letters Patent for the invention of certain improvements in treating certain ores and alloys, and in obtaining metals and other products therefrom, was, according to order, read the third time.

*Resolved*, That the Bill do pass.

*Ordered*, That the Clerk do carry the Bill to the Legislative Council, and desire their concurrence.

The House, according to Order, resolved itself into a Committee on the Bill respecting the Bar of *Lower Canada*; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Rémillard* reported, That the Committee had made some progress, and directed him to move for leave to sit again.

*Ordered*, That the Committee have leave to sit again, this day.

The House, according to Order, resolved itself into a Committee on the Bill to authorize the incorporation of the *Cobourg, Peterborough and Marmora* Railway and Mining Company; and after some time spent therein, Mr. Speaker resumed the Chair; and Mr. *Biggar* reported, That the Committee had gone through the Bill, and made an amendment thereunto.

*Ordered*, That the Report be now received.

Mr. *Biggar* reported the Bill accordingly; and the amendment was read and agreed to.

*Ordered*, That the Bill be read the third time, at the next sitting of the House.

The Order of the Day for the second reading of the Bill to incorporate the *Fenelon Falls, Minden, Haliburton* and Northern Lakes Steam Navigation Company, being read;

The Bill was accordingly read a second time; and referred to the Standing Committee on Banking and Commerce.

The House resumed the further consideration of the Resolutions on the subject of the Local Governments and Legislatures of *Upper and Lower Canada*.

*Ordered*, That the Question of concurrence be severally put upon each of the said Resolutions.

And the Question being proposed, That this House doth concur in the first of the said Resolutions;

And a Debate arising thereupon;

*Ordered*, That the Debate be adjourned until the next sitting of the House, and be then the first Order.

On motion of the Honorable Mr. *Galt*, seconded by the Honorable Mr. *Howland*,  
*Resolved*, That this House will, to-morrow, resolve itself into a Committee to consider the following proposed Resolutions:—

1. It shall be lawful for the Governor in Council to authorize the issue of Provincial notes payable on demand, of such denominations as may be determined upon, to an amount not exceeding five millions of dollars, and to re-issue the same. Such notes shall be a legal tender, and shall be redeemable in specie on presentation at Offices to be established at *Montreal* and *Toronto*, according as the said notes may be made payable.

2. It shall be lawful for the Governor in Council to enter into arrangements with any or all of the Chartered Banks of this Province, for the surrender of their power to issue notes, on or before the first of January, 1868; and in compensation for such surrender an annual sum not exceeding five per cent. upon the amount of their circulation as established by the monthly return, upon the 30th April last, shall be payable to each Bank so surrendering its power, and redeeming its circulation, until the expiration of its charter. And the Receiver General shall exchange the Provincial Debentures now held by such Banks
