Ordered, that Mr. Mabey do go to the Council, and request the said conference.

Ordered, that Mr. M'Neill, Mr. Mabey and Mr. Lewellin be a committee to manage

the said conference.

On motion, the House resolved itself into a committee of the whole House, on the consideration of Supplies to be granted for the Public Service.

10. RESOLVED, - That the sum of Twenty Shillings per day be paid to the Speaker of this House, for his services this Session.

11. Resolved,—That there be granted and paid the sum of Ten Shillings per day, to each of the Members of this House, for his services this Session.
