## THE EMMERSON LIBEL SUIT.

Preliminary Hearing Before the Fredericton Police Magistrate Last Week.

### CONFLICTING EVIDENCE.

The Case Sent Up To The Circuit Court, Over Which Judge Landry Will Preside.

The suit brought by Hon. H. R. Emmerson against the Fredericton Gleaner for criminal libel was tried before Police Magistrate Marsh in Fredericton on the 29th and 30th ult. The suit was brought because of the following paragraph in an editorial in the Gleaner of March 27th last:—

"This minister was Mr. Emmerson himself, and one of the places from which he was ejected with two women of ill-repute, with whom he had been keeping company, not long since was the St. Lawrence Hall, Montreal."

Premier Pugsley, J. H. Barry and ex-Attorney General White appeared for the prosecution and Mayor McLeod, J. D. Hazen, —, C., and the defendant's brother, O. S. Crockett, M. P., appeared for Jas. H. Crockett editor of the Gleaner.

Hon. Mr. Emmerson on the stand said that on Thursday, June 8th, 1906, he was travelling from Dorchester to Montreal, accompanied by his mother, sister and daughter. Stopping at Moncton Thursday night, Mr. and Mrs. G. Allan met him and asked him if he would take Mrs. Allan in his private car as far as Montreal, and Mr. Emmerson agreed. Mrs. Allan had been a very intimate friend of his late wife, and he had known her since her childhood. The party left Moncton for Montreal on Friday morning, June 9th, arriving at Montreal about 6.30 that evening. At Levis, Mrs. Beuthner, a friend of Mrs. Allan's, was taken on board. He did not know Mrs. Beuthner intended to come on board, till Mrs. Allan mentioned it just before they reached Levis. He had met Mrs. Beuthner one summer, knew she had visited Mrs. LaBilloy, and believed her to be eminently respectable. He considered Mrs. Allan to be of the best repute.

At Montreal, Mrs. Emmerson left for Toronto, Mrs. Allan and Mrs. Beuthner left the train, and Mr. Emmerson and his sister and daughter went to Ottawa.

Saturday night Mr. Emmerson returned to Montreal, and went to St. Lawrence Hall to see Mr. Joshua Peters of Moncton, who always stopped there. Looking over the register he saw the names of Mesdames Allan and Beuthner and went to their room for a short talk. He then took them to the Oxford restaurant for supper. Returning, he left them and went to his own room and retired. About midnight, he was awakened by the ladies knocking at his door. Hurriedly dressing, he admitted them, and they said they had been insulted by the porter. Mrs. Beuthner was hysterical and wished to leave the house. A porter came and apologized for what the other had said, but Mrs. Beuthner determined to leave. Then Mr. Emmerson asked one of the ladies to settle his account for him while he finished dressing, and then all three drove to the Albin Hotel,

which house he thought was one of good repute.

Mr. John Lloyd, night clerk in St. Lawrence Hall, employed there for 36 years, said that two porters had brought complaints to him about 1.30 in the morning. The Court forbade witness to state what the complaints were.

Then one of the ladies came very angry, and about ten minutes afterwards came again and paid her bill and Mr. Emmerson's. Then the three left.

Porter Harry Dean said that about midnight he saw two ladies go towards Mr. Emmerson's room. Shortly afterward, he noticed Room No. 9, taken by Mrs. Allan and Mrs. Beuthner, with door open and empty. About 1.30 he heard loud voices and laughter of ladies and a gentleman in Mr. Emmerson's room, and knocked at the door. In two or three minutes, a tall lady whom he recognized as one who belonged to No. 9, opened the door, and he told her the occupants must not make such a noise.

He reported to night clerk. Then he came again and told the occupants they must keep quiet or leave. One of the ladies followed him, and the gentleman went in another direction. Soon he saw the three leave the hotel.

Court adjourned till Monday. On Monday, the Judge sent the case up to Circuit Court, which meets on the 18th inst., in Fredericton, Judge Landry presiding.

## ROBINSON THE NEW PREMIER.

Hon. Mr. Pugsley Resigns And Hands Over Reins to Hon. C. W. Robinson of Moncton.

### THE NEW EXECUTIVE.

Premier Will Consult With His Supporters Concerning Cabinet Changes.

Late on Friday afternoon the Hon. Wm. Pugsley, premier and attorney general, placed in the hands of the Lieut. Governor his resignation which immediately sent for the Hon. Clifford W. Robinson and called upon him to form a cabinet. Mr. Robinson accepted the premiership. Friday night the new premier announced to his honor that he had selected his government as follows:

Premier, provincial secretary and attorney general—Hon. C. W. Robinson.

Commissioner of Public Works—Hon. C. H. Labilloy.

Surveyor general—Hon. F. J. Sweeney.

Solicitor general—Hon. W. P. Jones.

Commissioner of agriculture—Hon. L. P. Farris.

The governor accompanied by his secretary, R. S. Barker, met the newly appointed cabinet, with the exception of Mr. Farris, who is in England, in the executive council room where the oath of office was administered by the clerk of the executive J. Howe Dickson.

The new premier intends to act as attorney general until he has opportunity to consult fully with the members of his government and with his supporters regarding the selection of a man to fill the portfolio. He expected to be able to announce his decision in four days. It is understood that other changes in the government will also be announced soon. Report says two new members are to be appointed. Premier Robinson is being warmly congratulated by hosts of friends.

### I. C. R. RAISES WAGES.

A basis of agreement has been reached between I. C. R. machinists and General Manager Pottinger and Mechanical Superintendent Joughins. The increases agreed upon are as follows: Machinists now receiving 15 cents are increased to 20 cents per hour; men receiving 20 cents are advanced to 24 cents; 24 cent men advanced to 27, and those receiving 27 to 29 cents, from the first of last April.

### RESULT OF THE VOTE.
