GOVERNOR WILMOT AND ORANGEISM.

GOVERNOR WILMOT, we see by the Upper Province papers, is in Ottawa, spending a few days. His Honor's health this summer has not been good, and it is hinted that the drainage and ventilation about Government House are in a measure responsible. The truth is, we believe, that the Governor is not so much at home in the position he has taken, as in the position he left; and that the free, fresh breezes of Belmont were far more in sympathy with his mind and body in summer than the loss rampant surroundings and flatter breezes of Government House. We hope, however His Honor will return quite restored.

GOVERNOR WILMOT, like all the rest of us, in his giddy days sowed a few wild oats. In his early days he became an Orangeman, and when the Twelfth came round, he left farm and home and hanging on the meaningless yellow, followed the crowd. While the excesses of youth may be said to be drafts upon old age payable with interest, we have no desire now, to reproach our Governor for what he did then. Young men are giddy and impulsive. They care nothing for consequences and feel no responsibilities. It is hard to think that Mr Wilmot could have been different. Now, however, that his sun is low, and he has trod much upon the world's broad road, he sees in the light of clearer reason and better judgment the follies of 40 years ago. We think it is many years since he has first put on the tawdry yellow and offered insult to thousands who have never done him wrong, and who wished to live at peace with him and every other creed. Indeed, we learn it was the purpose of the Orangemen to present His Honor with an address in the Exhibition building on the 12th; and that they had signified to him their intention of doing so; but it is pleasing to note that he bore so well in mind what was due to himself as Governor, and to the people whom he governs, that he left the city before the 12th.

JOHN PICKARD, M. P.
 In wide contrast to the dignified act of the Governor, comes up Mr John Pickard's disgraceful exhibition of himself through the streets on the 12th in that Orange coach. Such an exhibition was bad enough for John A. Beckwith, who, as we have already said, has all the world like an unopened rose before him, but for Mr Pickard who has spent so many years among enlightened and broad-minded men, to make such a parade of his weakness, is more suicidal than stupid. For a number of years Mr Pickard has represented the county of York, and during all these years he has had the warm and generous support of the Roman Catholics. It didn't matter who came into the field, they had the impression that John Pickard was an honest and worthy man, and so they voted for him. The Freeman, which is so hatefully disposed towards Orangemen, had written many a diatribe in his favor, and this in itself covered a multitude of sins. In the face of these facts, Mr Pickard's persistent adherence to his early bigotry is incomprehensibly stupid.
 Low in the horizon hangs Mr Pickard's political sun; that day

he exhibited himself through the streets, accomplished its setting. When Mr Pickard first appeared before this county, asking for election, no other man whom the people knew put himself forward; and the masses cared little, and knew less about Dominion politics. Mr Pickard was returned, and has represented us since in the Commons where he has sat, like a log of wood. Next time he comes out he will stay out; for the men who stood by him in the past, and who in return he has wantonly and grossly insulted, will cast their votes for some more deserving man, while the crowd he tried to propitiate by putting on his yellow, and exhibiting himself through the streets with Hon. John A. Beckwith, will be forgetful of his sacrifice, and give their votes to some other. It is stupid bigotry like Mr Pickard that keep the fires of discord burning,—while men like Hon. John A. Beckwith parade in Orange for the promotion of some high moral end. It is a pretty spectacle truly, on this part of the globe in the year 1880, to find a lot of stupid bigots trying again to fan into a flame the old fires which burned on the banks of the Boyne in 1690. Catholics here do not want to subvert the laws, or undermine the throne, or fasten the fetters on liberty; they want to let by-gones be by-gones, and to live in peace and good-will with their neighbors. The Boyne and Aughrim have been fought and won,—and William has long since broken his neck—but they are satisfied that that should go. They have accepted the results with cheerfulness, and without murmur. They do not object to hearing of the Boyne, for they read it in their histories; but they do object, and they should be more or less than human if they did not object to a lot of ignorant bigots, who had no more to do with the Boyne than they had flaunting their mouldy yellow in their faces, and stirring them up to recrimination. Mr. Wilson, the Grand Master, we regret has not turned his talents to a better use than going around crookedly astraddle of an old cart horse, insulting men who never did him an injury. Mr Wilson can count in this city hundreds of Catholics who are warm friends of his, and who would pull a vote for him tomorrow if he wanted it; yet the way he acknowledges this is to head the rakings of the Province through the streets, in a procession whose prime and present object is to insult those same Catholics. We think Mr Wilson will soon see the absurdity of his ways and seek a more decent popularity—because, we think, he has a mind capable of good and generous things. As for Mr Pickard, he is hopelessly gone. He must seek fame in the future elsewhere than in the Commons;—perhaps it is the drowning man catching at the straw, and he now is depending for the notoriety which will result from a ride through the streets with Hon John A. Beckwith in a cloud of dust and yellow ribbons, rather than on that which he has so long enjoyed, but to which neither his learning nor his abilities entitled him.

Lt.-COLONEL MAUNSELL.
 Lt.-Colonel Maunsell, D. A. G., has received notice from the Militia Department to hold himself in readiness to be transferred from the Province the 1st January. Colonel Maunsell has not yet received any intimation where he will be sent to. We must say it gives us a good deal of regret to make this statement. Colonel Maunsell has lived in Fredericton now for many years, and no doubt he had indulged the hope of passing the rest of his days among the wide circle of friends which through his affable and genial manner he has made, and on his lovely farm to which he gave so much time and energy in beautifying.
 It may be that the interests of the Militia service demand the change; if it does, we stand confessed of being unable to see how. Perhaps the Militia service is to be abolished in this quarter; if it is, our only regrets shall be at Colonel Maunsell's going; but if it is to be maintained as it is, we must repeat we fail to see why the removal. Colonel Maunsell, however, may desire to go; if he does, then there seems little point to our article; but let us again repeat, if it is his wish to remain, and the military organization is to be continued here, we think nothing will be gained by the change, while our community will regret Colonel Maunsell's going, at the same time that he himself experiences all the disagreeableness of breaking up house, and severing ties, and going to goodness only knows where.

CONVICTS.

At an early hour on Friday morning, the sixty-one male convicts in the Penitentiary were manacled and conveyed to the North street Railway Station, leaving there in the regular train for Dorchester. Nearly all were comparatively new prisoners, but there was one, a Lascar, named Gabriel Moriano, who had not breathed the air of freedom for twenty-nine years. He was tried in 1851 for the murder of the mate of a vessel shortly after leaving the port, convicted and sentenced to death, but it being seen he did not realize that he had committed any serious offence, and to hang him would almost be like murder, sentence was commuted to imprisonment for life. When H. R. H. the Prince of Wales visited St. John twenty years ago, pardon was granted to Moriano, but he did not understand the meaning of it, and could not be induced to leave the prison, so he has been kept there ever since.

LORD ELPHINSTON.
 As will be seen by another column, the new New Brunswick Railway Company has gone up the line to see the road of which they are in a few days to assume the proprietorship. Lord Elphinstone we understand, is also one of the Company, and is a "Lord with more than a title." We believe this is the same nobleman who recently purchased and stocked a magnificent farm at Riding Mountain, in the North-West Territory. He is a young man and has taken a deep interest in Canadian enterprises. He is already engaged in several private and corporate speculations. We believe the quantity of his shares in the New Brunswick Road is considerable.

A COLD WAVE COMING.
 Mr. Vennor some time ago in the columns of the Argus, Albany, N. Y., predicted the occurrence, shortly after the 20th of July, of a "cold wave," with fall-like weather, frosts and "possibly snow falls in mountainous country." This he again reiterates in a letter to the Witness, expressing confidence in his first impressions, and stating that he already already has observed the speedy approach of this wintry blast in his clippings from the American newspapers. The frosts, he says, are likely to be widely experienced.
