PUNISHMENT IS TOO MILD

Foreign Envoys Will Not Accept the Imperial Edict.

Sentencing Prince Tuan and His Bloodthirsty Colleagues.

The Emperor Has No Strong Advisers -Russian Bombast.

London, Nov. 20. - Official advices received at Paris from the commander of the French troops in China, announce that international columns are occupying the tombs east and southwest of Pekin. He reports small engagements with Boxers, in which they lost three hundred killed, the foreign troops sustaining no casualties.

EDICT TOO EASY. The Morning Post's Pekin correspondent, wiring Sunday, says: "The edict inflicting punishment is milder than the first report suggested. Prince Tuan and Prince Chwang are only banished, and not imprisoned. Duke Lan is merely dismissed. The foreign envoys cannot accept the edict, owing

to the inadequacy of the punishings. Li Hung Chang submits it as the final punishment the court is able to inflict, and repeats the stereotyped plea of all Chinese plenipotentiaries, namely, that the emperor threatens himself and Prince Ching with severe punishment if they fail to induce the representatives of the powers to accept the compromise. The midness of the sentence excites ridicule and strengthens the ministers in their de-termination to demand the death penalty. The punishments are illusory. Prince Tuan is merely banished from his own home, and others undergo

retirement. DANGER AHEAD YET. London, Nov. 20.—"It is rumored," says the Pekin correspondent of the Morning Post, "that a spring expedition to Sian Fu is already being discussed, as the outcome of the peace negotiations. Emperor Kwang Su is helpless, as he leads the sid of a stream. helpless, as he lacks the aid of a strong and progressive adviser, all such offi-

cials having been beheaded. "Gen. Tung Fu Hsiang, master of the military forces, is dreaded even by the empress dowager. The new cabinet minister, Lu Chuan Lin, is reported to be another Kang Yi. There is danger, therefore, that terms accepted by the Chinese commissioners in Pekin

will be rejected at Sian Fu. "Should the court prepare for further resistance, it would be necessary for the ailies to declare war, but to discriminate between the court and China. The United States and Russia will probably refuse to take part in

such measures. "Since the occupation of Pekin the German commander has shot more than a hundred guilty Boxers. Chaffee's orders do not provide for dealing with cases of crimes committed before the relief of the legations. The American plan is to leave such matters to the Chinese, which means

nothing.' RUSSIAN BOMBAST.

The St. Petersburg correspondent of the London Times gives the text of Gen. Gribsky's proclamation, threat-ening to wipe out whole towns of Manchus if any resistance is made to the Russian annexation of the province. Here is a portion of it: "A month ago you committed the insolent absurdity of attacking Blagovestchensk and the Russian inhabitants, forgetting how terribly strong is the great Russian czar in land, people

and guns. "For that you have been severely

punished. "The town of Aigun and the villages along the banks of the Amur, the in-habitants of which dared to fall upon the Russians, have been burned.

"Your troops are destroyed, and the water of the Amur is polluted by masses of dead bodies of Manchus. "The Russians will soon enter all your towns and villages, and this is my solemn word

"Do not fire upon us or cause harm to our troops or to peaceful workmen engaged on the railway, but woe betide anyone who dares to shoot at or otherwise injure a Russian.

"His village or town shall be burned

to the grounds, and not one of its inhabitants left alive. "Turn a deaf ear to evil counselors who urge you to fight with us. They are your enemies, and will bring you

to ruin and death. "Woe be unto you if you do otherwise than as we command you!" BITS OF CHINA.

THE COURT'S TIME WASTED

Justice Meredith Scores Dilatory Witnesses and Lawyers.

The Long-Pending and Somewhat Famous Taylor-Davis Will Case Under Way.

At the sitting this morning of the non-jury assizes, the attention of the court was occupied by the hearing of the Taylor-Davis will case, which for over a year has been pending trial. It was nearly 11:45 before the case was opened, as Mr. Justice Meredith had to rise twice in order to allow Mr. A. B. Aylesworth, Q. C., counsel for the plaintiffs, to arrive from Toronto. The judge expressed himself strongly as to the way in which the court's time is wasted by dilatory witnesses or lawyers, and threatened to dismiss the case should not the parties be ready

to go on by a certain time. The parties in the will case mentioned are Helen Taylor and Isabella Smith, vs. Rev. Evans Davis, Robert Grant Fisher, Llewellyn Davis, Evans G. Davis, Gwendoline Davis, Llanarth William Davis, Isabella Trinier and Hannah Dickey, by original writ; and Sarah A. Keffer, Rev. Evans Davis, personally, the Diocese of Algoma, and the bishop thereof, representing the mission fund of the diocese, and the Incorporated Synod of the Diocese of Huron, representing the mission fund thereof, added party defendants, by or-

The plaintiff, Mrs. Helen Taylor, of Pickering, Ontario county, and the plaintiff, Mrs. Isabella Smith, of Amadore, Sanilac county, Michigan, are suing to set aside a will claimed by de-fendants to have been made by the plaintiff's sister, the late Margaret A. Burkholder, who died in this city on Aug. 30, 1899, leaving an estate of \$5,-500, consisting for the most part of a

cash bank deposit.
This will named the defendants, Rev. Evans Davis and R. G. Fisher, barrister, as executors, and left the bulk of deceased's property to the four infant children of the first-named defendant. The plaintiffs allege that the will was not executed by Margaret Burkholder, or, if it was executed by her, she was of an advanced age and in a state of extreme mental and physical weakness, and was not possessed of sufficient understanding to legally execute the will. The plaintiffs also allege that for months previous to the execution of this will, the defendan Rev. Evans Davis, was in constant communication with the deceased as her spiritual adviser, and in that capacity acquired such an influence over her that she was not capable of exercising her own free will and opinion,

and for these reasons they ask that the will be set aside. The defendant, Mrs. Isabella Trinier, of Orillia, Ont., and the defendant, Hannah Dickey, of Stayner, Ont., are nieces of the plaintiffs and the deceased, and they are added as defendants in order that in event of an intes-

tacy being declared, their rights might

be determined by the court. In the statement of defense, filed at the time of the first entering of the case, Mrs. Dickey claimed a share in the estate, and asked to have her share apportioned by the court; while Mrs. Trinier disclaims and share in the estate, and asked to have the case as against her dismissed with costs. Both the defendants Mrs. Trinier and Mrs. Dickey now ask to have their share apportioned by the court in the event of the will being set aside, as they would then be next of kin. The parties are represented by the following legal gentlemen: A. B. Aylesworth, Q.C., Toronto, and R. M. C. Toothe for plaintiffs Helen Taylor and Isabella Smith; T. G. Meredith for defendant Archdeacon Davis; J. C. Judd for defendant R. G. Fisher; Cronyn for John Hoskin, official guar-

event of the setting aside of the will; W. Cook, Toronto, for Sarah A. Kef-This case was first entered for trial at the spring assizes in March last, and was postponed till the non-jury sittings in April. At that court the trial judge postponed the case till the present court, in order that the beneficiaries under a previous will might be made parties to the suit. These beneficiaries were the mission funds of the Dioceses of Algoma and Huron, Sarah A. Keffer, a niece of the deceased, and Rev. Evans Davis.

The first witness, Wm. Taylor, husband of the plaintiff, Helen Taylor, deposed that there was insanity in the family of his wife and her sister, Mrs. Burkholder. Their father was deranged for ten or twelve years previous to his death; their brother Andrew was also insane, and committed sui-Witness said his wife's memory had failed, but otherwise she seemed to be in fair mental health.

James Smith, of 430 Dufferin avenue, had known Mrs. Burkholder intimate-by for over 31 years, she having been for some years an inmate of his house. He would not say she was insane, but she was very peculiar. Her memory failed greatly before her death, and she could not remember old acquaint-ances, but she remembered her relatives. Mrs. Burkholder had told witness that Rev. Mr. Davis had wanted her to leave her money to missions, and had told her he wanted \$2,000 to educate his two sons, telling her that this was mission work. Mrs. Burkholder told witness that she didn't think it was mission work; that she had worked hard for her money, and

She had told witness that Mr. Davis had wanted to take her bankbook and take care of her money for her. Miss Margaret Smith, sister of the previous witness, told of the stay at her home of Mrs. Burkholder, and of circumstances connected therewith. She gave instances showing Mrs. Burkholder's loss of memory. Mrs. Burkholder frequently spoke to witness of her intended disposition of her proper-ty, but each time she seemed undecidd, and often changed her intentions. Miss Smith's evidence was followed by that of Mrs.Locke, of London South,

at whose house Mrs. Burkholder was a resident for some time The case continued throughout the afternoon, there being a large array of witnesses.

CASE DISMISSED. Yesterday afternoon, the case of Robinson vs. Mann was heard and dismissed. The action was brought by Alfred Robinson, assignee of the estate of Walter Mann, bicycle deal-er, to set aside a chattel mortgage for \$1,200, made by Walter Mann to Geo. T.
