Motion of instruction not in order once bill has received second reading, 1607-08

Should stand when sponsor or someone authorized to act in his behalf is not in the chamber. However, (as) this is probably the last evening on which these bills will be called the hon. member may speak if he wishes, 4219

Under our practice an order for resuming the adjourned debate on the second reading of a private member's bill is proceeded with only at the instance of the sponsor of the bill or of a member authorized to act on the sponsor's behalf. Otherwise the order is allowed to stand until the next sitting day, 4087-88

Resolution stage

Discussion should be on general principle, 2212

No right of reply on M. for, unless with the unanimous consent of the house, 3483

Second reading

Amendment which seeks change in principle of bill, allowed to stand for decision of house, 1136-38, 1143

Discussion should relate to the principle of the amending bill, 206

Document must not be read from if it does not apply to principle of bill, 2771-72

House should consider principle of the bill and not its clauses, 2550

Members representative of various parties granted a limited time to express views on matters not specifically mentioned in bill, 2963

Not customary to ask questions of ministers on, 1174

Not in order to refer to sections at this time, 3613

Member/Members

Conversing with other members, asked to do so as quietly as possible, and preferably outside the chamber, 946

Leaving the chamber, . . . do so as quietly as possible, 946

Making point . . . just made. He can make these representations at the close of the debate when he replies, 2773

May ask a question with the consent of the member speaking, or rise to a point of order, 765

May continue speech after time has expired only with unanimous consent of the house, 330

Member has spoken in this debate . . . the rules prevent his speaking a second time, 1453

Must be in his seat or else his vote cannot be recorded, 2321

Must not impute motives to another member, 2772

No member shall walk out of or across the house, or make any noise or disturbance when question is being put, 2321

Not in order to read letters or newspaper articles expressing any opinion reflecting on proceedings within the house, 3940-41

Not to refer further to debate in the Senate, 1474
