Mr. Gauthier (Portneuf): I have just consulted with the hon, members for Labelle and Roberval about trying to obtain the permission of the house to call the Quebec schedule as one item because there are only two very minor changes to be made in item 27 and item 39, I believe. I do not say we never had any discussions in the Quebec committee, but we kept the discussions within the family circle and everything was done with the full co-operation of the ministers from Quebec and the members from Quebec on both sides of the house. I say that because we have had the full co-operation of all members of the subcommittee including the members for Trois-Rivières, Notre-Dame-de-Grâce, St. Denis, Bellechasse and Portneuf. I think we should be allowed to bring in the schedule as one item.

The Chairman: Is it agreed that all the items for Quebec be called at once?

Some hon. Members: Agreed.

Mr. Gauthier (Portneuf): I would like to move:

That the schedule, with respect to the province of Quebec, be amended by deleting paragraph (c) at the end of the description of the electoral district "27. Longueuil" and by adding the said paragraph (c) at the end of the description of electoral district "39. Richelieu-Verchères."

I would also like to move:

That the schedule with respect to the province of Quebec be amended by substituting the words "Saint-Jacques" for the words "St. James" at the beginning of paragraph 72.

In the case of Trois-Rivières the name was not translated and we would ask that here the name be not translated into St. James.

Mr. Graydon: Is it going to be Saint-Jacques street?

Mr. Gauthier (Portneuf): It is always Saint-Jacques street but you can call it St. James if you like.
