REPORTED REDUCTION IN TRANSCONTINENTAL SERVICE

Fisher (Port Arthur): Mr. Speaker, I should like to ask the Minister of Transport whether he has given any consideration to the urgent requests that I know he and other members have received regarding the cancellation for the winter months by the Canadian National Railways of its transcontinental trains Nos. 3 and 4.

Leon Balcer (Minister of Transport): Mr. Speaker, as the house knows, curtailment of service, short of abandonment of a line, can be decided upon by the railways themselves without applying to the board of transport commissioners; but if anyone feels that his rights have been infringed or that the interests of the public are at stake he can always apply to the board of transport commissioners.

Mr. Fisher: A supplementary question. Will the minister consider following the practice adopted by his predecessor in office in 1960 of making representations to the railways that led at that time to the ending of this curtailment idea?

Mr. Balcer: I have not received any representations yet but as soon as I receive any I will study the matter.

EXTERNAL AFFAIRS

NATO-REDUCTION OF R.C.A.F. COMMITMENT

On the orders of the day:
