## NATIONAL FILM BOARD

ALLEGED INITIAL RELEASE TO UNITED STATES VIEWERS

On the orders of the day:

Hon. Judy V. LaMarsh (Secretary of State): Mr. Speaker, yesterday the hon. member for Mégantic (Mr. Langlois) raised a question with respect to a film produced by the National Film Board, and quoted a story in the New York *Times*. His complaint was that a film had been produced by an agency of government, the National Film Board, and had been shown for the first time in the United States.

I have now ascertained that the facts are as follows: The film was premiered in English on the C.B.C.'s English television network on May 15 last, and in French on the French network on May 29. Twenty nine English prints have been in circulation since June in Canada, and 16 French language prints since July. The occasion to which the hon. member referred was perhaps the first private showing to a private audience in New York, and I am informed that the attendance included the Canadian Consul General. However, the film has been widely released in Canada for over five months.

As to the film content I am informed it is not a racist film. It was built around a Toronto man who was interned in concentration camps during the war, and who took his son back to the camps on a pilgrimage to expose him to the horrors which took place there. The film is called by a very learned film viewer, Pat Pearce of Montreal a "philosophy on film". It has been entered in international film festivals at Venice, San Francisco, Montreal and Vancouver and has won a prize at each.

## FINANCE

INQUIRY CONCERNING REPORT OF CARTER COMMISSION
