CHURCHILL, MAN.—STORAGE IN TERMINAL ELEVATOR

Mr. Robert Simpson (Churchill): Mr. Speaker, I wish to direct a question to the Minister of Finance. In view of the fact that the Canadian National is satisfied it has sufficient box cars available to fill the elevators at Churchill and in view of the fact that the wheat board is of the opinion that the Canadian National has not sufficient box cars to haul the grain which the wheat board would like it to haul, will the minister not ask the top authorities of the Canadian National and the wheat board to get together to decide whether the elevators in Churchill can be filled this winter?
