CONTROL BY BANK OF CANADA OF INTEREST RATES

## Question No. 220-Mr. Robinson:

- 1. What can or will the Bank of Canada do to limit the interest charged by the Chartered Banks and that paid to depositors by the Chartered Banks?
- 2. How can the Bank of Canada control the interest rates charged by (near banks) trust companies and finance companies?
- 3. What changes in legislation would be necessary to make the Bank of Canada more effective in curbing inflation?
- 4. What control is exerted by the Bank of Canada over advertising by the Chartered Banks?
- 5. What would be the estimated results if the Bank of Canada limited the interest rate chargeable by the Chartered Banks and lending institutions?

Hon. E. J. Benson (Minister of Finance): In so far as the Bank of Canada is concerned: 1, 2 and 3. The Bank of Canada exerts an important influence on the general level of interest rates and other credit conditions by using the powers which Parliament has given it in the Bank of Canada Act, mainly those powers which allow it to control the cash reserve base of the chartered banks as a group, and in this way to control the rate of expansion of the banking system. Additional powers would require further amendment of the Bank of Canada Act. Competition between banks and other financial institutions and in financial markets generally for the available funds causes this influence to spread through the whole system. The Bank of Canada has no statutory power to fix or to limit directly the interest rates charged or paid by the chartered banks or other institutions.
