

*Inquiries of the Ministry***THE CANADIAN ECONOMY****FOREIGN OWNERSHIP—IMPLEMENTATION OF WATKINS  
REPORT RECOMMENDATIONS—ESTABLISHMENT OF  
MONITORING AGENCY**

**Mr. Max Saltzman (Waterloo):** Mr. Speaker, I would like to direct my question to the Acting Prime Minister. In view of the recent measures taken by the United States which adversely affect our national economy, would the government consider implementing without further delay the recommendations of the Watkins report on foreign ownership and the recommendation of the House committee on foreign affairs to set up an agency to monitor the activities of foreign-owned subsidiaries?

**Hon. Mitchell Sharp (Acting Prime Minister):** Mr. Speaker, I would not like to waffle in my answer. The government, of course, has adopted some of the recommendations of the task force that was established by my predecessor when Mr. Watkins was not quite as extreme in his views as he is today.

**Mr. Saltzman:** In light of his answer, can the Acting Prime Minister indicate whether the government has any plans to monitor foreign-owned corporations to make sure they do not divert production from Canada to the United States?

**Mr. Sharp:** No, Mr. Speaker, there is no intention of establishing such an agency but the government has other means of knowing what is going on in these corporations and ensuring that they obey Canadian law and not American law, as his leader has said.

**Mr. Réal Caouette (Témiscamingue):** Mr. Speaker, I should like to put a supplementary question to the Acting Prime Minister.

The former Minister of Communications, the hon. member for Duvernay, stated yesterday that our policy should provide for a liberal monetary action capable of satisfying our capital requirements, that is, that the provinces should borrow in this country, and that the Bank of Canada should make funds available through financial channels—

**TRANSPORT****TOBERMORY-SOUTH BAY FERRY SERVICE—ACTION TO  
REMOVE BOTTLENECK**

**Hon. Donald C. Jamieson (Minister of Transport):** Mr. Speaker, a number of meetings have been held with the government of the province of Ontario, the most recent on July 26 or July 27. Our officials have subsequently met and the idea is to try to find some federal-provincial agreement under which this service would both be improved and ultimate responsibility for it assumed by the province of Ontario. I would hope that can be done during the fall.
