SUGGESTED INVESTIGATION TO DETERMINE WHETHER DOMINION STORES ADVERTISING MISLEADING

Mr. Ed Nelson (Burnaby-Seymour): Mr. Speaker, my question is directed to the Minister of Consumer and Corporate Affairs. In view of the fact that today's advertising by Dominion Stores claims that Dominion Stores has "spearheaded an industry-wide downward spiral of pricing" at this time, is the minister prepared to investigate this statement in order to determine whether or not it constitutes misleading advertising, as articulated by the Criminal Code?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): Mr. Speaker, I will draw the hon. member's question to the attention of the officials responsible for the administration of this part of the Combines Investigation Act, and we will wait to see what the result of the investigation may be.

FISHERIES

PROVISION OF INFORMATION ON ICE CONDITIONS, FOREIGN FISHING FLEETS AND LOCATION OF WRECKS AND OTHER OBSTACLES

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, I think I should point out to the hon. member that responsibility for the Bedford Institute, except in one respect, is no longer with my department. I would have to examine the question of to what extent I or my colleague can respond to it.

that their plan would have to be a national plan and naturally it would be a plan that all hog producers in Canada would have to approve.

Mr. Murta: In view of the fact the minister has stated in various speeches that hog producers have shown an interest in a national marketing agency, is he just echoing his own wishes that this is the kind of thing he personally would like to see?

Mr. Speaker: Order, please.

Mr. Whelan: On a point of order, Mr. Speaker, may I say that the hog producers made their representations to the national marketing council, not to me. They have voiced these views to me.
