REQUEST FOR CLARIFICATION OF GOVERNMENT ATTITUDE TOWARDS FORCE—MOTION UNDER S.O. 43

I would move, seconded by the hon. member for Lethbridge (Mr. Hurlburt):

That the Prime Minister advise the House forthwith whether the statements concerning the RCMP made by the Minister without Portfolio represent the attitude and policy of his government, or whether government policy is more accurately represented by the rebuking words spoken in this regard by the Solicitor General, and if the latter is the case, that the Prime Minister on behalf of the government forthwith apologize publicly to the RCMP and at the same time advise the House what date is already tentatively set for the appointment of the Minister without Portfolio to the Senate.

PROPOSED CREATION OF OFFICE OF OMBUDSMAN—MOTION UNDER S.O. 43

REQUEST FOR CLARIFICATION OF POLICY STATEMENT BY CHAIRMAN—DATE OF PUBLICATION OF REGULATIONS

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, I have a question for the Minister of Finance arising out of the report this morning that the chairman of the Anti-Inflation Board said in Toronto that the board has deliberately taken a rough initial stand on wage matters and will later soften its approach. Will the minister explain what the chairman has in mind or is this just an indication, to borrow an eloquent phrase used by the chairman of the board, that it is simply an indication that the board is prematurely dying with its brains on.

**Hon. Donald S. Macdonald (Minister of Finance):** Mr. Speaker, the government has appointed the membership of
