## REHIRING OF LAID-OFF PERSONNEL

**Hon. Walter Baker (Nepean-Carleton):** Using the analogy of the Postmaster General, who now says we are under a Liberal government with its generosity toward public servants, I wonder whether the President of the Treasury Board would tell the House what is intended by him with respect to a host of professionals and other public servants who were laid off by his government in 1978, some of whom have been placed but many of whom have not been placed notwithstanding promises made by that government that they would be placed.

Hon. Donald J. Johnston (President of the Treasury Board): I would remind the hon. gentleman that no lay-off policy was introduced by the Liberal administration. He may be referring to the policy introduced by my predecessor, the hon. member for York-Peel, who had to introduce such a policy when he inferred that he would eliminate 60,000 jobs in the public service.

The hon. member knows very well that efforts to find other employment within the public service for people laid off because of the Liberal constraint program preceding May 22, 1979, have been exceedingly successful.

**Mr. Baker** (Nepean-Carleton): Surely the minister must be aware of the famous shot in the dark of the night by the Prime Minister on August 1, 1978, when lay-offs of public servants began. The Prime Minister can aim Justin's gun at me if he wants, but that is what happened to the public service. One of the things that Liberals—
