

the House appreciates the difficulties being faced by small businesses across the country.

Small businesses were encouraged in April when the minister indicated he would bring in a small business development bond this year. In a press release on June 13, he indicated again that the bond would soon be introduced in the House. At this stage it would appear unlikely to be brought in this session. In view of the fact that it will take two to three months for the banks to implement this piece of legislation on behalf of small businesses, this government might have the distinction of implementing policy after it has expired. Would the minister please indicate to the House when the small business development bond will be introduced?

**Hon. Pierre Bussières (Minister of State, Finance):** Madam Speaker, in his question the hon. member referred to the fact that the Minister of Finance has already had, in a new release, the opportunity of indicating what guidelines will govern that technique. I can assure him that the Minister of Finance and the Minister of Justice will give urgent attention to the preparation of that legislation. The minister did indicate, when he tabled the ways and means motion in April, that he wanted that legislation, once it was tabled, to be discussed sufficiently to acquaint the House with the details of its application. In addition, the Minister of Finance still intends to make that information available to small businesses as soon as possible.
