Oral Questions

Hon. Lloyd Axworthy (Minister of Employment and Immigration): Madam Speaker, I would be very pleased to look into the specific matter which the Hon. Member has brought to my attention. I would like to point out, however, that under the National Training Act we do make available pre-skills training programs to local community colleges and organizations which want to sponsor pre-skills pre-trades programs where they can help individuals get up to a certain level of competence, whether it is in mathematics, English, or other basic skills, so that they can become eligible for the longer-term training programs. We are prepared to help with funding under that program. I would be very pleased to provide information to the Hon. Member so she could pass it on to those in her own constituency who might want to start such programs.

REFUNDABLE EMPLOYMENT TAX CREDIT PROPOSED FOR WOMEN

Mrs. Jennifer Cossitt (Leeds-Grenville): Madam Speaker, my question is for the Minister of Finance. Almost one-half of single-parent families headed by women are today living in poverty. The rate of unemployment among these women has increased by 60 per cent over the last year. Will the Minister consider a targeted refundable employment tax credit, or wage subsidy program, for this particular group? This is a concept which has been put forward by my colleagues on other occasions, and which has been endorsed in general terms by the Economic Council of Canada.

ADVICE GIVEN BY GOVERNOR

human tragedy going on, would the Minister of Finance not agree that the Governor of the Bank of Canada has entered the never-never land of Peter Pan and has really lost touch with the people of Canada and the realities of Canada?

Hon. Marc Lalonde (Minister of Finance): Madam Speaker, the Hon. Member is wrong on several points. The Governor of the Bank of Canada did not make a speech last Friday. He gave a press conference. Also he did not state what the Hon. Member attributes to him. I have read the transcript of the Governor's statement, and he did not say what the Hon. Member says he said.

REQUEST THAT ANNUAL REPORT BE LAST SUBMITTED BY GOVERNOR

Mr. Nelson A. Riis (Kamloops-Shuswap): Madam Speaker, Governor Bouey's advice to the Minister of Finance in his annual report is very clear. He is advising more of the same. POSITIONS OF GOVERNOR AND MINISTER
