Sir William Mulock, as Minister of Sir William Mulock, as Minister of Labor, replied to the deputation. He said the government appreciated the fact that the industrial community of Canada viewed with approval the pol-icy and legislation of the government for the welfare of the working classes. No nation rested upon a sure founda-tion unless the great mass of its indut-rial people were fairly prosperous, con-tented and happy, and therefore in adopting measures that contributed to the welfare and happiness of the toiladopting measures that contributed to the welfare and happiness of the toil-ers the government were contributing to the stability of Canadian institu-tions. The deputation had submitted a number of interesting questions, and these would be brought to the govern-ment's notice. "We recognize, how-kever," said the minister, "the per-fect freedom in Canada of people with-in the law to form such associations as they will for their happiness, their protection and their advancement, and protection and their advancement, and as a government, speaking generally, we are against any act which savors we are against any act which awards of compulsion or coercion, as contrary to the views of the Liberal party. In Canada we would take the view that any organization not violating the law should be supported." Sir William supplemented the foregoing with a few remedie in Frinch remarks in French.


