Toronto, Jan. 10.—Burglars stole \$31.-000 worth of diamonds and other jewelry from the safe of Pacquette. Hughes, manufacturing jewelers, over the week-end, using electric-driven drills and acetylene blow torches.

The robbery was discovered this morning by Mrs. Gates Pacquette and Robert Hughes. There are four large holes drilled through the combinations of both outside and inside doors. The door of the inside safe was badly burnt and the shelves were scorched.

"We had over \$31,000 worth of jewelry, including \$5,000 of loose diamonds, \$15,000 of diamond jewelry, besides other stone jewelry," said Mr. Pacquette today. "Our stock is covered by \$20,000 insurance, taken out two months ago."


CERTIFY TO ELECTION.

#### PAN-AMERICAN LABOR CONFERENCE OPENS IN CAPITAL OF MEXICO

Mexico City, Jan. 10.—Delegates from labor organizations of the United States, Mexico and sixteen South and Central American republics were here today for the opening session of the third Pan-American Federation of Labor conference. Samuel Gompers, president of the American Federation of Labor, and fourteen other representatives of United States labor organizations made up the delegation from the United States.

It was expected the conference could be brought to a conclusion before the end of the week. The purpose of the gathering, according to Mr. Gompers, was "to promote good relations among the laborers of the United States, Mexico and South and Central America."

The first Pan-American federation conference was held in Laredo, Texas, in November, 1918, while the second occurred in New York City in July, 1919.

J. E. Keenleyside Was Early Bird At G. T. R. Station Today.

Nineteen cases of imperial "nose paint," labeled "paint," was what License Inspector J. E. Keenleyside got for being one of e early birds at the Grand Trunk station this morning.

This consignment, which was billed as doming from McArthur, Irwin & Co., a Montreal paint and dye firm, to H. Gill of Exeter, originally consisted of 25 cases. Replying to the vote of thanks for performing this office he expressed the best wishes for the success of the aldermen in their work for a year, and jocularly remarked that he hoped harmony would prevail at least to the extent where there would be no bottle throwing.
