

When Mr. Asquith, as prime minister, visited Buckingham Palace just before the new parliament assembled he had lunched well, if not wisely. At the time he was ushered into the presence of the King he still showed the marks and signs of the generous luncheon of an hour or so before.

The object of Premier Asquith's visit was to exact a pledge from King Edward to sustain the government's stand in the matter of abolishing the veto in the house of lords. 
