Expenditure Roads, &c.	A Bill to continue the Act to regulate the Expenditure of Monies hereafter to be appropriated for the service of Roads and Bridges, and the Acts in amendment thereof.
Bridgeport Harbor Master	A Bill to continue the Act for establishing a Harbour Master at Bridgeport, in the Island of Cape-Breton.
Coals by weight	A Bill to continue the Act to authorize the Sale of Coals by weight.
Kings County Landings	A Bill to continue the Act to regulate certain Landings in the County of King's County.
Lunenburg Fire Engines	A Bill to continue the Act to enable the Inhabitants of the Town of Lunenburg to procure a Fire Engine, with other utensils and materials, necessary for extinguishing Fires.
Am. Bank of N. S.	A Bill to continue the Act to amend the Act to Incorporate sundry persons by the name of the President, Directors and Company, of the Bank of Nova-Scotia.
Wickwire Dyke	A Bill to continue the Act relative to the assessment of Dyke Rates, for the New or Wickwire Dyke in Horton.
Survey of Timber	A Bill to continue the Act to regulate the Survey of Timber and Lumber, and to repeal certain Acts now in force.
Fisheries Lunenburg	A Bill to continue the Act to prevent Injuries to the Fisheries within the County of Lunenburg, by Mill Dams, or any other obstructions.
Supervisors of Public Grounds	A Bill to continue the Acts for appointing Supervisors to take charge of Public Grounds, and for other purposes.
Sable Island	A Bill to continue the Act for the better regulation of Sable Island, in this Province.
Fishermens Nets	A Bill to continue the Act to prevent damage to the Nets of Fishermen by Coasting Vessels.
Settlement of Poor	A Bill to continue the Act in amendment of the Act for the settlement of the Poor in the several Townships within this Province.
Nuisances additional	A Bill to continue the Act additional concerning Nuisances.
Weighing of Beef	A Bill to continue the Act to regulate the Weighing of Beef, and the Acts in amendment thereof.
Militia	A Bill to continue the Act for regulating the Militia.
Chedabucto Fisheries	A Bill to continue the Act for the regulation of the Fisheries at Chedabucto Bay.
Read 1st time	To which Bills they desired the concurrence of this House.
Ref. to Sel. Com.	The said Bills were read a first time.
Committee	Ordered, That the said Bills be referred to a Select Committee to examine and report upon.
