His Excellency's Speech from the Throne considered; Resolution, that a Supply be granted to Her Majesty; To be considered in committee of the whole; So much of the Speech as relates thereto referred, 42. Considered, 62. Report on Resolution, that a Supply be granted to Her Majesty; House to go into committee to consider of such Supply, 74. Message with Estimates referred, 81. House goes into committee, 90.—Report one Resolution; Agreed to; Motion that the Speaker do now leave the Chair (to go into committee); Amendment, that the Reciprocity Treaty with the U. States is an object of the utmost importance, and to secure that object, &c., the enlargement of the Welland and St. Lawrence Canals should be prosecuted at the earliest possible period, negatived; House goes into committee, 97, 138, 150, 153, 166, 168, 181, 183. Supplementary Estimates referred, 152. Report several Resolutions; Agreed to, 184, 187, 188, 190, 215.

2. House resolves to go into committee of Ways and Means, 97. Considered, 115, 218. Report a Resolution; Agreed to, 218. Bill presented, 219. (See *Promissory Notes*.) Report four Resolutions, granting \$5,006,145.02 out of the Consolidated Revenue Fund, \$22,200 out of the L. Canada Building and Jury Fund, and \$25,000 out of the U. Canada Building Fund;—and authorising \$1,000,000 to be raised by debentures, or Provincial stock, on the credit of the Consolidated Revenue Fund; Agreed to, 237. Bill presented, 238. See *infra*, 3.

3. Bill for granting to Her Majesty certain sums required for defraying certain expenses of the Civil Government, for the year ending 30th June, 1866, and for other purposes connected with the Public Service; Ordered, 237. Presented; Read thrice, and passed, 238. By the Council, 271. R. A., 276. (29 Vic., c. 2.)

4. Supply Resolutions reported, and reception of Report postponed to a future day. 90, 151, &c.—Ways and Means, 218. Resolutions reported, and report received forthwith.—Regulating fees, 199.—Imposing duties, 217.
