

Printing of the Legislature, presented to the House the Fifth Report of the said Committee, which was read, as followeth:—

The Committee have carefully examined the documents referred to in the following Motions for Printing, viz.:—

By Mr. *McKellar*,—Return to Address, for all Tenders received for the delivery of Rations and Firewood for the use of the Volunteers on the Western Frontier, from the time they were placed on duty in 1865. The Committee recommend that this document be printed for distribution, and in the English language only.

By Honorable Mr. *McDougall*,—Report of the Superintendent of Education for *Upper Canada* for 1865. The Committee recommend that this document be printed in the usual form, and the usual number.

By Mr. *Biggar*,—Report of the Select Committee appointed to enquire into the expediency of constructing a Canal to connect the head waters of the Bay of *Quinté* with *Lake Ontario*, usually called the "*Murray Canal*," &c. The Committee recommend that this Report be printed.

By Mr. *Mackenzie*,—Report of Mr. *Torrance*, Commissioner appointed to enquire into the circumstances connected with the release, by Judge *Coursol*, of the prisoners accused of robbing the Banks at *St. Albans*, (as laid before the House last Session,) and also, a reference back to the Committee of the Return to Address of this Session, for Report of *F. W. Torrance, Esq.*, Commissioner of Inquiry into matters connected with release of prisoners accused of having robbed the Banks of *St. Albans*. The Committee recommend that both the above documents be printed, for distribution only.

By Mr. *Mackenzie*,—A reference back to the Committee of the Return and Supplementary Return to an Address, respecting leaves of absence granted to Judges of *Lower Canada*, &c. The Committee recommend that certain portions only be printed, and for distribution only.

The Committee also recommend that the following documents be printed, viz.:—

Return to Address, relative to a change of proprietors of the *Beauport* Asylum, and the support of the Lunatics in the said Asylum.

And that additional copies of the Report of the Commissioners from *British North America* appointed to inquire into the trade of the *West Indies, Mexico* and *Brazil*, 3,180 in English and 1,475 in French, be printed.

The Honorable Mr. Solicitor General *Langevin* reported, from the Select Committee on the Bill, from the Legislative Council, intituled, "An Act to facilitate the repression of the evils caused by intemperance in *Lower Canada*," that the Committee had gone through the Bill, and made amendments thereunto.

A Bill to amend the Act incorporating the *Quebec* Marine Insurance Company, was, according to Order, read the third time.

On motion of the Honorable Mr. *Alley*, seconded by the Honorable Mr. *Rose*, the Bill was amended by leaving out Clause 3, and inserting the following instead thereof:—

3 "No risks against Fires shall be taken by the said Company until the present Stock of the Company be subscribed for, to the extent of four hundred thousand dollars (including that already subscribed), nor until one hundred thousand dollars (including what has already been paid up) shall be paid up."

*Resolved*, That the Bill do pass.

*Ordered*, That the Clerk do carry the Bill to the Legislative Council, and desire their concurrence.

The Order of the Day for the third reading of the Bill to legalize a certain Agreement between the *Buffalo* and *Lake Huron* Railway Company and the Grand Trunk Railway Company of *Canada*, being read;

The Honorable Mr. *Rose* moved, seconded by the Honorable Mr. *Alley*, and the Question being proposed, That the Bill be now read the third time;

Mr. *McKellar* moved, in amendment, seconded by Mr. *Mackenzie*, That all the words after "now," to the end of the Question, be left out, and the words "re-committed to a Committee of the whole House, with instructions to expunge that portion of the Bill
