### STRIKES AND LOCKOUTS WITHOUT BOARD ACTION PROHIBITED BY NEW LAW

Act Recently Quashed by Privy Council Is Revamped and Approved by Commons-Government Is Confident New Law Will Stand Against Any Attacks Made Upon Its Validity-Now Goes To the Senate.

PROVIDES PENALTIES UP TO \$1,000 A DAY

Parliament Buildings, Ottawa, May 13.-Important legislation went through all stages in the House of Commons this afternoon in the form of a bill designed to restore to usefulness the industrial disputes investigation act, which was quashed some months ago by a decision of the judicial committee of the privy council in England. The act was declared ultra vires of the dominion parliament in

that it infringed on provincial rights. The amending bill restricts the application of the statute to matters outside the jurisdiction of the provinces. The government believes that, as it is now amended, this measure, which has proved so serviceable since its enactment in 1907, will stand against any assault made upon its validity, and that it will again prove useful in the settlement of industrial disputes and prevent strikes and lockouts.

New Act Was Urged.

The minister of justice, Mr. Laointe, told the House that employers and employees in large numbers had requested the government to revive the industrial disputes investigations ine industrial disputes investigations act. To this end the amendments had been framed, with the views of the privy council in mind. Under the amended statute it will be unlawful for an employer to put into effect changes in wages or hours or for employees to strike until the dispute has been dealt with by a board of conciliation. A fine of from \$100 to \$1,000 for every day that a lockout is forced may be levied on the employer. #### THREE CHANGES IN ALL.

Ottawa, May 13.—With three thanges, the bill to amend the industrial disputes investigation act dustrial disputes investigation act (commonly known as the Lemieux act) went through all stages in the House today. The purpose of the bill, generally speaking, is to limit the application of the act to matters to within the legislative jurisdiction of any province. There is a further provision to enable any province to take advantage of the provisions of the dominion act should the desire. The changes embody visions of the dominion act should t so desire. The principal of the changes provide that employers and employees hall give at least 30 days' notice of in intended or desired change af-fecting wages or hours, and that, in event of a dispute, it will be unawful for the employer to make proposed changes or for the employees to go on strike until the dispute has been dealt with by a board. Further, hat an employer declaring a lockout making effective change in wages contrary to provisions of the act, will be liable to a fine of not less han \$100 and not more than \$1,000 for each day the lockout exists.

Ready For Foe.

Hon, Ernest Lapointe, minister of ustice, stated that the proposed legis-lation simply defined what the fed-eral government could do in labor matters. #### **GUN PLAY AIDS IN SALVAGE** OF SCOW AFTER LAKE STORM; **BATTLE MAY GO TO COURTS**

Sarnia Skipper Alleges Piracy When Tow Is

CUT FROM MOORING Salvage Crew Is Caught

Unawares by Bold Move. Special to The Advertiser.

Sarnia, May 13 .-- A skirmish between boat crews, in which revolvers are reported to have played a part and the alleged forcible seizure of a tug Favorite, are the echoes of a large steel scow by the crew of the storm on Lake Huron, in which a tow of steel scows broke away from the tug Favorite. Claims for salvage are said to be likely, and the problem may reach the courts.

The Favorite was coming down the lake on Sunday night with a tow of seven scows when the storm struck them. Large hawsers snapped and the scows went adrift. The tug crew managed to collect six of them and put into harbor. Monday morning she went after the missing scow and found that the freighter Raleigh had it in tow, having found it adrift and

with no person aboard.

It is reported that when the crew of the Favorite attempted to secure the scow they were driven off by Captain Rattray of the Raleigh who put into Harbor Beach with the scow and left it in charge of the officer in command of the beach coast guard. Later the Favorite put in and, making a line fast to the scow, pulled it from the moorings, and set off down the

lake. From Alpena comes a despatch, quoting Captain Rattray as saying that the action of the Favorite crew in attempting to take the scow from him was "an attempt at piracy," and the despatch also states that exciting stories are told by Seamen Horn and Johanson of the Raleigh, who were placed aboard the scow by Captain Rattray when he picked it up. The Rattray when he picked it up. The seamen claim that revolvers were displayed by the tug crew, while Captain Rattray admits that he used a revolver in his efforts to hold off the "attacking" crew.

It is likely that Captain Rattray will go to court to secure his salvage rights unless the question is settled by arbitration.
