Associated Press Despatch. Rome, Nov. 12.-The men behind the plot to assassinate Premier Mussolini planned to launch an armed revolt, if successful in removing the head of the Fascist regime, it was officially announced today by the investigating authorities.

The Fascist newspapers continue to charge that the plot against Mussolini and similar projects were organized in France.
