

MINING LAWS OF ONTARIO.

NY person may explore Crown Lands for minerals.

Mining lands may be taken up and A Mining lands may be taken up as surveyed locations or staked claims.

Claims range from 40 to 320 acres.
Claims range from 10 to 20 acres on vein or lode.
Locations may be acquired in fee or under leasehold.
Price of locations north of French River, \$2 to \$3 per acre, and south of it, \$2 to \$1.50, according to distance

Rent of locations first year 60c. to \$1 per acre, and

Rent of locations first year 60c. to \$1 per acre, and subsequent years 15c. to 25c. per acre.

Rent of claims, \$1 per acre each year.
Claims must be worked continuously.

Royalty on ores specified in the Act, 2 per cent. of value at pit's mouth less cost of labor and explosives.

Royalty not charged until seven years from date of patent or lease, nor (as provided in s. 4 (3) of the Mines' Act, 1892), until fifteen years in the case of an original discovery of one or mineral.

Original discoverer of ore or mineral on claim entitled to stake out a second claim.

Original discovered of the original of chain entitled to stake out a second claim.

Crown Lands sold under provisions of mining laws in force prior to 4th May, 1891, exempt from royalty.
