- 4. TO REAFFIRM THE MANDATE TO THE SECRETARY GENERAL OF THE OAS TO CONTINUE4 IN COORDINATION WITH THE SECRETARY GENERAL OF THE UN TO TAKE ACTION WITHIN THE FRAMEWORK OF THE CHARTER TO SEEK A PEACEFUL SETTLEMENT OF THE HAITIAN CRISIS.
- 5. TO COMMEND THOSE STATES WHICH ARE ADOPTING MEASURES TO STRENGTHEN THE EMBARGO WHICH IS AN IMPRIANT COMPLEMENT OF THE CURRENT NEGOTIATING PROCESS AND TO UNDERSCORE THE NEED TO HAVE ALL STATES MEMBERS OF THE OAS AND THE UN STRENGTHEN SUCH MEASURES PARTICULARLY AS REGARDS THE SHIPMENT OF PETROLEUM SUPPLIES AND BY PRODUCTS TO HAITI, AND SUSPENSION OF COMMERCIAL FLIGHTS
- 6. TO REQUEST THAT THE OAS EMBARGO COMMITTEE:

- (A) NAME A PERMANENT CHAIRPERSON TO LEAD THE WORK OF THE SPECIAL COMMITTEE AND
- (B) MAKE MONTHLY PUBLIC REPORTS OF FUTURE COMPLIANCE WITH THE EMBARGO TO THE PERMANENT COUNCIL AND TO REQUEST THE SECRETARY GENERAL OF THE CENERAL TO TRANSMIT SUCH REPORTS TO THE SECRETARY GENERAL OF THE UN.
- 7. TO REITERATE ITS SERIOUS CONCERN OVER THE CONTGINUOUS VIOLATIONS OF HUMAN RIGHTS BY THE MILITARY REGIME AND TO REITERATE TO THE INTER AMERICAN COMMISSION ON HUMAN RIGHTS THAT IT CONTINUE ITS ONGOING AND CLOSE MONITORING OF THE SITUATION IN HAITI AND REEP THIS AD HOC MEETING INFORMED THROUGH THE PERMANENT COUNCIL.
- 8. TO PROVIDE CONTINUED FULL SUPPORT TO THE EFFORTS MADE BY DR DANTE CAPUTO SPECIAL JOINT ENVOY OF THE SECRETARY GENERAL OF THE OAS AND OF THE SECRETARY GENERAL OF THE UN TO CONTRIBUTE TO THE SOLUTION OF THE HAITIAN CRISIS.
- 9. TO URGE THE STATES OF THE UN AS WELL AS THE INTERNATIONAL COMMUNTITY, THROUGH THE SECRETARIES GENERAL TO CONTINUE TO SUPPORT THE INTERNATIONAL CIVILIAN MISSION.
- 10. TO REQUEST THE SECRETARY GENERAL TO TRANSMIT THE PRESENT RESOLUTION TO THE SECRETARY GENERAL OF THE UN AND TO DISTRIBUTE IT.
