

Order in Council P.C. 2882, dated September 27, 1939: authorizing appointment of Press and Film Censorship personnel with compensations.

Order in Council P.C. 2891, dated September 27, 1939: amending Defence of Canada Regulations *re* printing of prejudicial statements.

Order in Council P.C. 2892, dated September 27, 1939: amending Prize Court Regulations established under Order in Council P.C. 2489, dated September 5, 1939.

Order in Council P.C. 2893, dated September 27, 1939: appointing S. R. M. Hodgins, Esquire, of Macdonald College, as Secretary of the Agricultural Supplies Committee at a salary of \$400 per month.

Order in Council P.C. 2894, dated September 27, 1939: respecting remuneration to be paid to examiners engaged in Postal Censorship of letters written in uncommon languages.

Order in Council P.C. 2896, dated September 27, 1939: amending Regulations of the Defence Purchasing Board respecting contracts.

Order in Council P.C. 2905, dated September 27, 1939: entering into an Agreement with the Ontario Fruit Export Association for the purchase of Ontario apples.

Order in Council P.C. 2921, dated September 28, 1939: authorizing War Supply Board to act as Agent for British Purchasing Mission.

Order in Council P.C. 2926, dated September 29, 1939: amending Defence of Canada Regulations *re* trespassing on premises used for the purpose of essential services such as electricity, gas or waterworks, sewage plants, municipal services, property and utilities.

Order in Council P.C. 2929, dated September 29, 1939: amending Defence of Canada Regulations *re* Senior Police Officers, Royal Canadian Mounted Police—search of premises, etc.

Order in Council P.C. 2851, dated October 3, 1939: appointing S. R. Noble, Esquire, of Montreal, as Sugar Administrator, with a living allowance of \$20 per diem.

Order in Council P.C. 2906, dated October 5, 1939: authorizing purchase and sale of fibre flax seed.

Order in Council P.C. 2975, dated October 3, 1939: appointing Maurice Samson, Esquire, of Quebec, as Hides and Leather Administrator, with a living allowance of \$20 per diem.

Order in Council P.C. 2976, dated October 3, 1939: appointing H. J. Hobbins, Esquire, Montreal, as Technical Advisor to the Sugar Administrator, with actual travelling and living expenses.

Order in Council P.C. 2997, dated October 5, 1939: prohibiting export of chum salmon in fresh state.

Order in Council P.C. 3004, dated October 5, 1939: authorizing hospitalization—Naval, Military and Air Forces—Pensions and National Health.
