Inquiries of the Ministry

the international joint commission made a report in connection with the proposed Passamaquoddy project?

Hon. L. B. Pearson (Secretary of State for External Affairs): In reply to the hon. member for Charlotte I would say that the international joint commission made its report to the two governments on October 23, 1950, recommending that a further investigation would be necessary to enable it to make recommendations concerning the feasibility of the Passamaquoddy project, and has estimated that such an investigation would cost \$3,900,000. The report suggests that the cost might be apportioned between the two countries in proportion to the benefits that each country would derive from the completed project. This report is still under study by the interested federal authorities, and has been referred to the government of New Brunswick.

CANADIAN CASUALTIES-PRESS REPORT AS TO LETTERS WRITTEN TO RELATIVES

On the orders of the day:

Mr. E. D. Fulton (Kamloops): Mr. Speaker, I should like to ask the Minister of Justice if his attention has been directed to reports in the press that the families of soldiers who have appeared on the casualty lists from Korea are receiving letters which, it is stated, must have been communistically inspired. If so, will he let us know what has been done to investigate the situation?

Hon. Stuart S. Garson (Minister of Justice): My attention has not been directed to the report in question, but on receipt of the information from my hon. friend I shall be glad to look into it at once.

An hon. Member: Common sense.

Mr. McIlraith: If I had had some notice of this question I could have looked up the exact reference in Beauchesne's parliamentary procedure.

## RENT CONTROL

QUESTION AS TO CONTINUANCE OF FEDERAL CONTROL AFTER APRIL 30

St. Laurent (Prime Minister): There has been no change in the policy of the government, announced several months ago, affecting nation-wide rent control, which will expire at the end of April. The information I have, obtained from the press rather than from official sources, is to the effect that most of the provincial governments are arranging to enter this field at that time.
