Mr. Martin:

1. Total amount paid during the fiscal year 1953-54 direct to public general hospitals (classified as such by the province or territory in which located) and as premiums to the British Columbia hospital insurance service covering almost all the native population in British Columbia-\$2,302,575.

It is not possible to compute an over-all average patient day cost because of the factor of insurance (almost all the native population in British Columbia are covered by the British Columbia hospital insurance service -hence payments are not made direct to individual hospitals but in the form of premiums).
