COMMONWEALTH CONFERENCE

INQUIRY AS TO POSSIBLE MEETING OF PRIME MINISTERS

Diefenbaker (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the Prime Minister and ask him whether the Prime Minister of Great Britain or any member of the British government has been in communication with the government of Canada with reference to the convening of a conference of commonwealth prime ministers and whether, if that is so, his attention has been directed to a Canadian Press dispatch to the effect that it is hoped to organize one shortly despite the reluctance of Canada. Is Canada reluctant with regard to the convening of such a conference? If so,

Right Hon. L. S. St. Laurent (Prime Minister): Mr. Speaker, Canada is not reluctant with regard to the convening of a conference at any time that can be arranged that will not interfere with the essential business that has to be done here. There is usually correspondence among the prime ministers when a conference is being arranged but, to my knowledge, there has been no correspondence up to the present time.

POSTAL SERVICE

NEW WESTMINSTER, B.C.-REFERENCE TO DIREC-TIVE TO PARCEL POST CARRIERS

Mr. F. G. J. Hahn (New Westminster): Mr. Speaker, I should like to direct a question to the Postmaster General. I regret that I was not able to give him too much notice of it.
