Mr. Herridge: Mr. Chairman, I am very sorry to have been unavoidably absent from the chamber when the minister introduced his estimates. When I heard they were before the house I promptly left my constituents and came down. I want to compliment him, as he is a minister with ideas. While we do not always agree with his application of ideas, he does put forward something that we can at least consider. I think he puts forward some progressive measures. I also wish to express my appreciation of the work done by the staff of the forestry branch, both in the forest products laboratory and in the field. I have known many of them for a good number of years.

I am wondering if there is any difficulty in this department's obtaining the staff it requires to undertake the necessary research, both in the laboratory and in field operations. If there are any staff shortages at the present time, could the minister explain to the house the reason why those shortages prevail? I also want to know what co-operation exists between federal and provincial governments, the universities, and industry with respect to the planning of research, and what these persons who are particularly interested in development and research consider to be the most important aspects of research to be undertaken at any given time. I should like the minister to point out one or two examples of research being carried on in particular fields that will be easily recognized by the greater number of people engaged in and interested in the development of the forestry industry.

> I wish now to direct the minister's attention to one aspect of policy which in the opinion of several of us has not received sufficient attention from his department. It may seem strange, coming from a pragmatic socialist, but I have in mind particularly the private ownership of forests by individuals or by small companies. I was recently at a meeting where this matter was the subject of considerable discussion. It was generally agreed that a clear definition of policy was needed from both federal and provincial governments on the management of private woodlands.

> We think this type of development is coextensive with the development of the economic family farm and that it should be encouraged by both levels of government. While the discussion to which I referred was taking place a good many persons expressed the opinion that there had been a notable absence of any expression of interest in this phase of resource development on the part of the federal and provincial departments directly concerned. I should like to hear the minister's views on this question.

This brings me to the subject of the literature published by the department, expecially by the forest products laboratory. I wonder whether this literature is reaching as wide a segment of our population as it should. I have followed this work for 20 years. It is excellent work and I believe it is necessary that it should be undertaken. I have a great deal of respect for the staff which is undertaking this. I knew Colonel Jenkins personally.
